Lobbying activities relate to the passage of the 2015 and 2016 capital plans to ensure receipt of matching funds from New York State. Also lobbied Nassau County Legislature for passage of Ordinance 4-2016 which gave authorization to the County Executive to accept an offer of purchase from Nassau County in trust for the purposes of Nassau Community College of a parcel of real property, and authorizing the County Executive to consummate the sale for the benefit of the College.
