





Narrative

Purpose: This contract consists of the repair/replacement of equipment and mitigation of two (2) wastewater pumping stations (Sage Lake and Lawrence) damaged by Superstorm Sandy.

Procurement History: The contract was publicly bid on May 17, 2016 and it is recommended that award be made to the lowest responsible bidder, Philip Ross Industries, Inc., who submitted a successful low bid of \$4,900,000.

Discussion: This construction contract provides for furnishing all labor, materials & equipment required for construction-related services. The contract is FEMA-eligible and includes repair/rehabilitation, code compliance & flood mitigation measures to 'harden' the stations against future storm surges, as occurred during Superstorm Sandy. It is envisioned to have a construction duration of twenty (20) months.

Impact on Funding: The bid for this Contract of \$4,900,000 is below the engineer's estimate and funding is available under Capital Project No. CSW 3P311. It is expected that this contract will be eligible for reimbursement by FEMA under the Robert T. Stafford Disaster Relief & Emergency Assistance Act.

Recommendation: It is recommended that this contract be approved as submitted.

We have completed our evaluation of the bids received on May 17, 2016 for Contract 10C. Our evaluation compared the bids received with the Engineer's Estimate of \$5,320,537 for the scope of work, including items added by Addendum 1 and 2. A total of 3 bids were received for this contract. Our evaluation is based on the bid results that were shared with us by the County on May 23, 2016.

The following summarizes the apparent low bidder for Contract 10C in comparison with the Engineer's Estimate dated April 08, 2016.

10C	\$5,320,537	Philip Ross Industries, Inc.	\$4,900,000

The apparent low bidder was Philip Ross Industries, Inc. with a bid price of \$4,900,000 (including Allowances 1 and 2). This low bid is approximately 7.90% lower than the Engineer's Estimate of \$5,320,537. The second lowest bidder was RJ Industries with a bid of \$5,575,500 which is about 12.11% higher than the apparent low bid and about 4.8% lower than the Engineer's Estimate. The third lowest bidder was Posillico Civil, Inc with a bid of \$5,835,500 which is about 16.03% higher than the apparent low bid and about 8.8% lower than the Engineer's Estimate. Please find attached a copy of the summary of bid opening.

The average of the 3 bids for Contract 10C is \$5,437,000 and the highest bid was \$5,835,500.

The following table is a comparison of the apparent low bid from Philip Ross Industries, Inc to the Engineer's Estimate and the differences between the two.




