Description: Re-Entry Coordinator, Contract Manager, Mentoring, Internships, Educational & Sports Programs targeting recently incarcerated individuals and high-risk youth for Hempstead Community Improvement Project.

Purpose: To utilize grant funding awarded to the District Attorney's Office for the Hempstead Community Improvement Project. This is a one year extension of an agreement to provide services to previously incarcerated individuals to improve their chances at rebuilding their lives as productive members of the community and will engage at-risk youth in constructive activities to reduce gang involvement.

Method of Procurement: Family & Children's Association (FCA) has been performing these services since 2010 as part of the Hempstead Community Improvement Project. This Contractor has a long standing relationship with the community and a vocational education site in Hempstead, has prior experience providing similar services to the community with much success. The contractor was selected because it is the only local agency which possesses the necessary qualifications, skills, experience, ties to the community, and specialized access to the Nassau

Procurement History: In the fall of 2007 the Nassau County District Attorney's Office began the Hempstead Terrace Bedell Initiative. The Hempstead Community Improvement Project is part of that initiative. Both federal and state funding have been utilized to continue this project. All contracts resulting from this program have been entered into in accordance with applicable Nassau County rules and procedures regarding procurement.

Description of General Provisions: A twelve month extension of an agreement in the amount of Four Hundred and Seventy-One Thousand Five Hundred and Twenty Dollars (\$471,520.00) for a Re-entry Coordinator, Contract Manager, Mentoring, Internships and Educational and Sports Programs.

Impact on Funding / Price Analysis: None, contract is 100% grant funded and/or funded by discretionary forfeiture funds.

Change in Contract from Prior Procurement: None. Previous agreement was for same amount.





Heading In A New Direction



CLIENT STORY

Back in 2009, I was 25-when I was mandated by the courts to begin treatment for my marijuana use. I was smoking pot daily and believed it was no big deal. As a requirement for my treatment with FCA, I had to abstain from drug use. I figured I'd do what had to be done for the moment but would probably go back to smoking once the program was over. Less than a year later, when I finished with the program, my abstinence was intact. What? I realized that I had learned to live without pot; somehow I learned to deal with my thoughts, apsetting events and even emotions without smoking weed. I was happy to end my treatment and get on with my life.

Then in 2014, I decided to return to FCA, this time voluntarily. I got older and had come to a crossroads in my life and realized my former addiction had made me unmotivated, uninvolved in my future and unprepared for a career. It was time to do something about it. So, I began treatment again to strengthen my recovery and joined your Vocational Education program and obtained a high school equivalency diploma setting myself up for acceptance at trade school: Today, I'm licensed, working and soler—thanks to FCA.

TACKLING ADDICTION

Heroin use has exploded in what is being described as an epidemic on Long Island. This has been a growing issue over the last 15 years and now law enforcement and the mental health community have been forced to play "catch up" in trying to stem the tide of addiction. In search of a high, youth pay only \$10 for a package of heroin versus \$80 for an 80-milligram pill of OxyContin. Underage drinking, the availability of starter drugs like marijuana and the low cost of heroin provide a fertile breeding ground for youth addiction. Substance use disorders impact one in four families, putting great strain on the physical, emotional and financial health of the individual, their family and our community.

CHANGING BEHAVIORS & CREATING OPPORTUNITIES

FCA offers adults and youth with behavioral health or substance abuse issues a pathway to stability, empowering them to build stronger, healthier lives. Our qualified health professionals, credentialed substance abuse counselors, social workers, psychiatrists and nurse practitioners deliver evidence-based treatment practices to individuals, couples and families. We offer education and information along with practical tools for managing mental health issues or changing unwanted behaviors or addictions. We assist our clients by engaging their loved ones in their recovery efforts; providing respite and childcare to parents; and offering vocational or ESL education to adults. Ours is a holistic, multi-disciplinary approach that treats psycho-social, psychiatric, substance abuse issues or co-occurring disorders.


We have two NYS OASAS-licensed outpatient treatment facilities that provide individual, group and family treatment for those struggling with addiction and substance use disorders, one in Hicksville and one in Hempstead. We're in the process of transforming our chemical dependency treatment center in Hempstead into the go-to place for families dealing with addiction. We'll look at how men and women respond differently to stressors that lead to reliance on drugs and alcohol and offer evidence-based treatment that brings results. We will be working towards ending addiction for the parent while simultaneously sharing prevention information and support to the family. As part of our commitment to mothers, we'll be offering free childcare at the center. We believe change is possible, and we give our clients a strong foundation from which to move forward.

But, I got arrested and had to meet with an FCA case manager as part of my probation and learned that I shouldn't always listen to my friends. My case manager found a local screen printing shop where I could volunteer every week and the owner even let me create custom designs for tee shirts. This was way cooler than just spray painting buildings.

I've been working with my case manager on being responsible for my actions and now my. 60 day probation is over and I'm doing well in school, at home and at my volunteer job.

CREATING OPPORTUNITIES FOR YOUTH

In 2014, we opened our Learning Center, a warm and hospitable place for young people to came for acceptance and to develop the confidence and skills they'll need to succeed. Many of the young people we assist come from underserved neighborhoods and failing school districts; some are homeless; some are in foster care and others are falling through the cracks at home and in school. At the Learning Center, all are welcome; we engage youth in meaningful exercises and workshops to help them develop the skills they need to prepare themselves for employment, college and successful adulthood. We invite volunteers from the business community to share their knowledge on subjects ranging from health and nutrition to job seeking skills or how to write a winning essay for a callege application. A key component of the Learning Center's mission is connecting these young people with compassionate and concerned adults who are willing to guide them and offer assistance and jobs that enable them to succeed. This mentor-mentee program is part of a larger Step Up to Success initiative which began in 2013 as a way of ensuring that clients receive the practical help they need to create positive change in their lives.


A FUND FOR THE FUTURE

DONOR STORY

I like to find good people and keep them for as long as I can. In keeping with this strategy, I hired seven youth from FCA's Step Up to Success initiative John, Jay, April, Nancy, Rachael, Ted and Steven. These young people are now part of the LI Frozen Storage learn in part-time or full-time positions where they can use their talents, continue their education and obtain valuable work experience.

In the past, there used to be a level of social mobility that people could attain through employment; if you worked hard enough you could improve your financial situation and obtain a standard of living that exceeded that of your parents. But today, it is very difficult to prove how hardworking you are when you can't get an entry level job without a college degree. That is why we hired young people sponsored by Family & Children's Association; we wanted to give them that initial opportunity they need to succeed. And we're thrilled with how they've responded. FCA did a great job of screening the applicants and gave us dedicated, hardworking kids.



STRENGTHENING FAMILIES


The challenges facing many Long Island families are complex; in addition to financial and substance abuse issues, FCA is seeing an increase in families with undiagnosed mental illness; medically-fragile children; and those diagnosed with Autism (or one of the disorders on the Autism spectrum).


In order to improve the lives of these children, from infancy through adolescence, we introduced evidence-based treatment programs such as "Strengthening Families" into our toolbox for transforming families in need. Staff in all family-focused programs received certification in this methodology allowing us to improve client outcomes. Parents gained greater control of their home environments, improved their parenting skills, time management and money management skills resulting in more stable home lives for their children.



AT RISK YOUTH

For families requesting a Person in Need of Supervision Petition from the court system for their challenging adolescent, our PINS Diversion program is the answer, Since 2011, we have saved 3,200 teens from entering the juvenile justice system, family court or out-of-home placement. And, in 2014 we successfully implemented a new team approach to provide multi-faceted counseling to the most difficult cases, because we believe that each child, no matter how resistant, deserves a chance to prosper. Our success rate, of more than 90% each year, translates into billions of dollars in savings to taxpayers. The impact on families is priceless.





CARING FOR THE GREATEST GENERATION

Each year, FCA serves nearly 9000 individuals who are 60 years of age and older. We focus on the individual needs of each person, providing a variety of services that enhance their well-being and support their life goals. For those living independently at home, we provide information, financial and health insurance counseling, home visits and referrals to available entitlements. For others who may be unable to manage their affairs or reside in adult/nursing facilities, we offer guardianship and advocacy to ensure they receive proper care. Our professional and caring staff gives seniors the help they need to live their lives with dignity.

ASSESSING & RESPONDING

Case managers and volunteers visit seniors in their homes and senior-care facilities to evaluate their situation and create a plan for their individual needs. Do they need help around the house or a healthcare aide? Are they entitled to free services such as Meals on Wheels, Friendly Visiting, food stamps or a free one-time delivery of home heating oil? Are they being cared for appropriately and with respect? Our staff and volunteers devote themselves to the concerns and proper care of Long Island's most vulnerable residents.

Working with seniors offers our volunteers opportunities to make a real contribution in a person's life: our bill payers, for example, visit clients' homes and help organize their paperwork and bills on a monthly basis. Our friendly visitors bring companionship and solace to those struggling with loneliness and isolation. Visits like these start out as a professional calls yet slowly morph into a visit between friends – and that's our community of caring at work.


A Happy Ending


CLIENT STORY

My house was severely damaged during Super Storm Sandy Thankfully I received money for repairs from FEMA but was hospitalized shortly. thereafter before I could arrange for reconstruction. Unfortunately, Lentrusted my son to take over doing the repairs but then he walked off with the balance of the money and I've been unable to locate him ever since. With nowhere else to go, I returned to my house after my hospitalization, but at 75 years of age, it's very difficult to live in such an unsafe and mold-infested place. A neighbor recommended I contact IsCA and with nowhere elseto turn, I made the call.

Tour senior financial counselors listened to my story and were very supportive; they helped mefigure out next steps and together we filled out the application for a reverse mortgage. This was a God send! I've gone through an assessment of my home and any now receiving monthly stipends in order to make repairs and remain in my home for the rest of my life. This is a happy ending to a terrible period in my life, all thanks to FCA.

STEP UP TO SUCCESS


In 2013, FCA brought together 17 young men and women from across our agency and inducted them into our Step Up to Success initiative (SU2S). This innovative project was designed to deliver the tools for successful adulthood into the hands of our clients, aged 16 24, who were homeless, in foster care or in failing schools. These young people presented with a wide range of challenges and varying degrees of readiness for independent living – in addition to histories of physical and/or emotional trauma. Results for the test phase were very promising: 14 out of the 18 clients moved up one or more rungs on our "ladder of success."


During our expansion phase in 2014, FCA enrolled 49 young men and women from across our agency and each was given sessions with a transition coach who delivered intensive, one-to-one counseling that focused on mastering 16 life skill sets or "domains." Skills such as job seeking, job maintenance, money management, housing, education, financial counseling and personal grooming were taught to

youth and their progress was closely monitored by staff. With financial support from donors, encouragement from caring mentors from the community, and job opportunities provided by Long Island-based companies, these young people earned a combined \$124,000 in direct income and financial aid awards; 84% of active clients were enrolled/attended school and 75% were employed.

Plans are underway to incorporate the Step Up to Success protocol into all divisions within the agency; full integration will occur in 2015.

In recognition of these results, FCA has been awarded significant funding for our youth emergency shelter and transitional residence. We will receive approximately \$180,000 per year for the next three years through a Basic Center Grant and nearly \$200,000 per year for the next five years from a Solutions to End Homelessness Program (STEHP) grant awarded by Office of Temporary and Disability Assistance (OTDA).







Learning How to Be a Family

CLIENT STORY

I was 16 when I was arrested. The police were called to our house because of a fight I was having with my dad. I was taken to jail and we ended up in Adolescent Diversion Court where the judge required us to participate in your PINS Diversion program. I really didn't want to go to the Strengthening Families group with my dad, but it was part of the program so I went along. It was tough in the beginning, but over time I started to see my dad in a different way. I could see that he was trying to learn how to listen and he tackled our homework assignments with enthusiasm, so I did too. After completing the program, my case was dismissed by the court! I was thrilled and also happier because it was nicer at home, our disagreements didn't automatically turn into screaming matches and fights. We learned how to get along and respect each other's opinions and now things are better for both of us. Thanks for the help.

The prospective lower tier participant shall provide immediate written notice to the person to which this proposal is submitted if at any time the prospective lower tier participant learns that its certification was erroneous when submitted or has become erroneous by reason of changed circumstances.
- 4. The terms "covered transaction," "debarred," "suspended," "ineligible," "lower tier covered transaction," "participant," "person," "primary covered transaction," "principal," "proposes," and "voluntarily excluded," as used in this clause, have the meanings set out in the Definitions and Coverage sections of rules implementing Executive Order 12649.
- 5. The prospective lower tier participant agrees by submitting this proposal that, should the proposed covered transaction be entered into, it shall not knowingly enter into any lower tier covered transaction with a person who is debarred, suspended, declared ineligible, or voluntarily excluded from participation in this covered transaction, unless authorized by the department or agency with which this transaction originated.
- 6. The prospective lower tier participant further agrees by submitting this proposal that it will include the clause titled, "Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion Lower Tier Covered Transaction," without modification in all lower tier covered transactions and in all solicitations for lower tier covered transactions.
- 7. A participant in a covered transaction may rely upon a certification of a prospective participant in a lower tier covered transaction that it is not debarred, suspended, ineligible, or voluntarily excluded from the covered transaction, unless it knows that the certification is emoneous. A participant may decide the method and frequency by which it determines the eligibility of its principals. Each participant may check the Nonprocurement List.
- 8. Nothing contained in the foregoing shall be construed to require establishment of a system of reports in order to render in good faith the certification required by this clause. The knowledge and information of a participant is not required to exceed that which is normally possessed by a prudent person in the ordinary course of business dealings.
- 9. Except for transactions authorized under paragraph 5 of these instructions, if a participant in a covered transaction knowingly enters into a lower tier covered transaction with a person who is suspended, debarred, ineligible, or voluntary excluded from participation in this transaction, in addition to other remedies available to the Federal Government, the department or agency with which this transaction originated may pursue available remedies, including suspension and/or debarment.

THIS AMENDMENT, dated as of <u>September 12</u>, 2016 (together with the schedules, appendices, attachments and exhibits, if any, this "<u>Amendment</u>"), is entered into by and between (i) Nassau County, a municipal corporation having its principal office at 1550 Franklin Avenue, Mineola, New York 11501 (the "<u>County</u>"), acting on behalf of the County Department of the District Attorney, having its principal office at 262 Old Country Road, Mineola, NY 11501 (the "<u>Department</u>"), and (<u>ii</u>) Family and Children's Association, a New York State not for profit corporation, having its principal office at 100 E. Old Country Road, Suite 24, Mineola, NY 11501 (the "<u>Contractor</u>").

WITNESSETH:

WHEREAS, pursuant to County contract number CQDA16000001 between the County and the Contractor, executed on behalf of the County on May 16, 2016 (the "Original Agreement"), the Contractor provides services to previously incarcerated individuals and high-risk youth as part of the Hempstead Community Improvement Project, which services are more fully described in the Original Agreement (the services contemplated by the Original Agreement, the "Services"); and

WHEREAS, the term of the Original Agreement is from July 1, 2015 to June 30, 2016, with four (4) one (1) year options to renew under the same terms and conditions, and subject to early termination as provided for under the Original Agreement (the "Original Term"); and

WHEREAS, the maximum amount that the County agreed to reimburse the Contractor for Services under the Original Agreement, as full compensation for the Services, was Four Hundred Seventy-One Thousand and Five Hundred and Twenty Dollars (\$471,520.00) (the "Maximum Amount"); and

WHEREAS, the County desires to exercise one (1) of the four (4) renewal options to renew the Original Term and increase the Maximum Amount.

NOW, THEREFORE, in consideration of the promises and mutual covenants contained in this Amendment, the parties agree as follows:

- 1. <u>Renewal of Term</u>. The Original Agreement shall be renewed and thereby extended by one (1) year, so that the termination date of the Original Agreement, as amended by this Amendment (the "<u>Amended Agreement</u>"), shall be June 30, 2017, subject to early termination as provided for under this Amended Agreement.
- 2. <u>Maximum Amount</u>. The Maximum Amount in the Original Agreement shall be increased by Four Hundred Seventy-One Thousand and Five Hundred and Twenty Dollars (\$471,520.00), so that the maximum amount that the County shall pay to the Contractor as full consideration for all Services provided under the Amended Agreement shall be Nine Hundred

Forty-three Thousand and Forty and 00/100 Dollars (\$943,040.00) (the "Amended Maximum Amount"). The increase provided under this Amendment shall be payable in accordance with the attached Appendix A-1.

3. <u>Full Force and Effect</u>. All the terms and conditions of the Original Agreement not expressly amended by this Amendment shall remain in full force and effect and govern the relationship of the parties for the term of the Amended Agreement.

Contract Summary

Description: Re-Entry Coordinator, Contract Manager, Mentoring, Internships, Educational & Sports Programs targeting recently incarcerated individuals and high-risk youth for Hempstead Community Improvement Project.

Purpose: To utilize grant funding awarded to the District Attorney's Office for the Hempstead Community Improvement Project. This agreement will provide services to address the needs of previously incarcerated individuals to improve their chances at rebuilding their lives as productive members of the community and will engage at-risk youth in constructive activities to reduce gang involvement. For this contract period, we are expanding the program's base of operation to the City of Long Beach.

Method of Procurement: Family & Children's Association (FCA) has been performing these services since 2010 as part of the Hempstead Community Improvement Project. This Contractor has a long standing relationship with the community and a vocational education site in Hempstead, has prior experience providing similar services to the community at an exemplary level. The contractor was selected because it is the only local agency which possesses the necessary qualifications, skills, experience, ties to the community, and specialized access to the Nassau County Correctional Center necessary to perform the services for this project.

Procurement History: In the fall of 2007 the Nassau County District Attorney's Office began the Hempstead Terrace Bedell Initiative. The Hempstead Community Improvement Project is part of that initiative. Both federal and state funding have been utilized to confinue this project. All contracts resulting from this program have been entered into in accordance with applicable Nassau County rules and procedures regarding procurement.

Description of General Previsions: A twelve month agreement in the amount of Four Hundred and Seventy-One Thousand Five Hundred and Twenty Dollars (\$471,520.00) for a Re-entry Coordinator, Contract Manager, Mentoring, Internships and Educational and Sports Programs connected with the District Attorney's Council on Thought and Action program in the Village of Hempstead and the City of Long Beach.

Impact on Funding / Price Analysis: None, contract is 100% grant funded and/or funded by discretionary forfeiture funds.

CONTRACT FOR SERVICES

WITNESSETH:

WHEREAS, the County desires to hire the Contractor to perform the services described in this Agreement; and

WHEREAS, this is a personal service contract within the intent and purview of Section 2206 of the County Charter; and

WHEREAS, the Contractor desires to perform the services described in this Agreement.

NOW, THEREFORE, in consideration of the premises and mutual covenants contained in this Agreement, the parties agree as follows:

- 1. Term. This Agreement shall commence on July 1, 2015 and terminate on June 30, 2016, unless sooner terminated in accordance with the provisions of this Agreement. The County at its sole discretion may renew this Agreement under the same terms and conditions for four (4) additional one (1) year terms.
- 2. Services. The Contractor shall provide services through the Council on Thought and Action ("COTA"), having bases of operation in both the Village of Hempstead and the City of Long Beach, New York. COTA functions as an alternative-to-incarceration prosecution option for adjudicating felony and misdemeanor cases in Nassau County, where pending cases are permitted upon court, defense, and prosecutor consent, to be diverted - upon conditional plea contract - to a self-sufficiency program curriculum that addresses facets of education, vocational training, child and family care, and life stabilization. It is measured by both educational and employment achievements. along with re-offense reduction, with the ultimate objective being an individual's successful "re-entry" into the community in a productive, law-abiding manner. COTA additionally provides re-entry services for conditionally-released defendants, accepting referrals from the Nassau County Probation Department and the New York State Department of Corrections and Community Supervision (DOCCS). Individuals (termed COTA's "clients" or "program participants") are selected for referral by these agencies based upon risk assessments, including lifestyle, gang affiliation, and support structure. All agency referrals are upon consent of a supervising prosecutor. Through its services to the court system, including post-release services, COTA strives to reduce the risk of re-offense.

facilitate re-entry, and mitigate collateral consequences of criminal convictions where possible. Where applicable, results and achievements are reported back to referring agencies. COTA receives ancillary clientele from at-risk individuals in the local communities, as assessed by an assistant district attorney, a referring law enforcement agency, or both. Social services provided by COTA are more fully described in the attached budget (APPENDIX A).

- a) Contract Manager -- The Contractor shall provide a contract manager to oversee program expenses and to monitor progress and performance in contract compliance and in attaining organizational goals.
- b) Re-Entry Case Managers The Contractor shall provide up to two (2) full-time and one (1) part-time Re-Entry Case Managers to perform all aspects of case management, including but not limited to assessment and meeting with COTA clients to provide resources and referrals to assist with housing, employment, family and parental support, health care, and alcohol and chemical dependency treatment.
 - (1) Facilitates pre-release visits at correctional facilities providing written plans.
 - (2) Provides direct counseling designed to motivate and focus COTA clients on implementing personal development.
 - (3) Provides advocacy, information and referral services including linkages to appropriate services. Maintains and develops service resources for clients.
 - (4) Provides vocational development skills essential to either entering or advancing in the job market.
 - (5) Provides casework services and crisis intervention to clients.
 - (6) Facilitates regular field visits as needed to support the client's goal attainment.
 - (7) Coordinates activities, trips, and transportation to enhance vocational and personal development skills for program participants.
 - (8) Achieves academic benchmarks for program participants and their dependents through application of the science, technology, engineering, art and mathematics (STEAM) program, compiling statistical data for learning objectives.
 - (9) Assumes other tasks and responsibilities assigned to support the operations of the COTA program.
- c) Re-Entry Outreach Workers In coordination and consultation with law enforcement partners and entities described above, the Contractor shall provide outreach services to ganginvolved, at-risk, currently incarcerated, and conditionally-released individuals. The Contractor shall also provide transportation to outreach workers on an as-needed basis. The Contractor shall also provide for incidentals essential to the running of the program.

- d) Administrative Assistants The Contractor shall provide up to two (2) administrative assistants to support the day-to-day administrative needs of the program. The responsibilities include but are not limited to typing, data collection, research, reporting and coordinating.
- e) **Program Assistant (STEAM)** The Contractor shall provide a program assistant to assist in the implementation of the COTA STEAM program in the City of Long Beach. Duties will include monthly tracking and compilation of statistical data for STEAM program goals and objectives.
- f) Mentoring/Enrichment Program The Contractor shall provide training and compensation to mentors who provide services and skill development to COTA clients. The Contractor will also provide for incidentals related to mentoring such as transportation, enrichment opportunity, clothing items, educational materials and supplies and personal hygiene items to assist COTA clients in personal development and in preparing for employment interviews and job opportunities.
- g) Internships The Contractor shall provide COTA clients with introductory training to develop skills in various employment areas. The Contractor shall also provide for incidentals essential to the running of the program.
- h) Educational Activities The Contractor shall provide training opportunities for COTA clients including, but not limited to, computer skills, certificate training, general equivalency diploma examination preparation and alcohol and substance abuse counselor training to enhance their chances for employment. The Contractor shall also provide for incidentals essential to the running of the program.
- i) Athletic/Team-Building Programs The Contractor shall operate apposite athletic programs to provide team-building, constructive and safe recreation. The Contractor shall also provide for incidentals essential to the running of the program,
- j) Re-Entry Staff Training -- The Contractor shall provide training to program staff and volunteers to develop and refine skills necessary to meet program mission and objectives. The Contractor shall also provide for incidentals essential to the running of the program.
- k) Trips The Contractor shall organize and provide trips for program participants to promote cultural enrichment and to encourage positive social norms, values and coping skills. The Contractor shall also provide for incidentals essential to the running of the program.
- I) Development of Informational Materials The Contractor shall provide graphic design, photography, and other informational and marketing materials such as t-shirts, pens and notebooks, to assist with outreach efforts promoting the program and its benefits to incarcerated and at-risk individuals and to provide information to community partners.
- m) Building Maintenance The Contractor shall pay for building maintenance which shall include pest control services on an as-needed basis at the locations where the Services are conducted.

n) Community Event Food Expenditures – food expenses related to community meetings including but not limited to community outreach, gang intervention and COTA meetings.

In addition, the Contractor shall submit to the Department monthly and quarterly client progress reports in such format approved by the Department which provide, at a minimum, the following information:

- (1) Number of clients seen.
- (2) What Contractor services were utilized?
- (3) Where were clients referred?
- 3. Payment. (a) Amount of Consideration. The amount to be paid to the Contractor as full consideration for the Contractor's services under this Agreement ("Maximum Amount") shall not exceed Four Hundred Seventy-One Thousand and Five Hundred and Twenty Dollars (\$471,520.00), payable in accordance with the attached budget, Appendix A.
- (b) Vouchers; Voucher Review, Approval and Audit. Payments shall be made to the Contractor in arrears and shall be contingent upon (i) the Contractor submitting a claim voucher (the "Voucher") in a form satisfactory to the County, that (a) states with reasonable specificity the services provided and the payment requested as consideration for such services, (b) certifies that the services rendered and the payment requested are in accordance with this Agreement, and (c) is accompanied by documentation satisfactory to the County supporting the amount claimed, and (ii) review, approval and audit of the Voucher by the Department and/or the County Comptroller or his or her duly designated representative (the "Comptroller").
- (c) <u>Timing of Payment Claims</u>. The Contractor shall submit claims no later than three (3) months following the County's receipt of the services that are the subject of the claim and no more frequently than once a month.
- (d) No Duplication of Payments. Payments under this Agreement shall not duplicate payments for any work performed or to be performed under other agreements between the Contractor and any funding source including the County.
- (e) <u>Payments in Connection with Termination or Notice of Termination</u>. Unless a provision of this Agreement expressly states otherwise, payments to the Contractor following the termination of this Agreement shall not exceed payments made as consideration for services that were (i) performed prior to termination, (ii) authorized by this Agreement to be performed, and (iii) not performed after the Contractor received notice that the County did not desire to receive such services.
- (f) Reimbursement by the Contractor upon Loss of Funding. In addition to any other remedies available to the County, in the event that the County loses funding, including reimbursement, from the State or federal government for any Services arising out of or in connection with any act or omission of the Contractor or a Contractor Agent (i) the County will have no further obligations to the Contractor under this Agreement and (ii) the Contractor shall pay the County the full amount of lost funds on demand, but not in excess of the amount paid to the Contractor under this Agreement.

- (g) Reallocation Among Line Items: The Contractor may reallocate monies within the budget, provided however, that the Contractor shall not reallocate more than ten percent (10%) of the amount allocated to any line item to another line item nor add or subtract a line item, without the prior written consent of the Department, Clause 10 notwithstanding.
- 4. Independent Contractor. The Contractor is an independent contractor of the County. The Contractor shall not, nor shall any officer, director, employee, servant, agent or independent contractor of the Contractor (a "Contractor Agent"), be (i) deemed a County employee, (ii) commit the County to any obligation, or (iii) hold itself, himself, or herself out as a County employee or Person with the authority to commit the County to any obligation. As used in this Agreement the word "Person" means any individual person, entity (including partnerships, corporations and limited liability companies), and government or political subdivision thereof (including agencies, bureaus, offices and departments thereof).
- 5. No Arrears or Default. The Contractor is not in arrears to the County upon any debt or contract and it is not in default as surety, contractor, or otherwise upon any obligation to the County, including any obligation to pay taxes to, or perform services for or on behalf of, the County.
- 6. Compliance with Law. (a) Generally. The Contractor shall comply with any and all applicable Federal, State and local Laws, including, but not limited to those relating to conflicts of interest, discrimination, a living wage, disclosure of information, and vendor registration, in connection with its performance under this Agreement. In furtherance of the foregoing, the Contractor is bound by and shall comply with the terms of Appendix EE attached hereto and with the County's vendor registration protocol. As used in this Agreement the word "Law" includes any and all statutes, local laws, ordinances, rules, regulations, applicable orders, and/or decrees, as the same may be amended from time to time, enacted, or adopted.
- (b) Nassau County Living Wage Law. Pursuant to LL 1-2006, as amended, and to the extent that a waiver has not been obtained in accordance with such law or any rules of the County Executive, the Contractor agrees as follows:
 - (i) Contractor shall comply with the applicable requirements of the Living Wage Law, as amended;
 - (ii) Failure to comply with the Living Wage Law, as amended, may constitute a material breach of this Agreement, the occurrence of which shall be determined solely by the County. Contractor has the right to cure such breach within thirty days of receipt of notice of breach from the County. In the event that such breach is not timely cured, the County may terminate this Agreement as well as exercise any other rights available to the County under applicable law.
 - (iii) It shall be a continuing obligation of the Contractor to inform the County of any material changes in the content of its certification of compliance, attached

as Appendix L, and shall provide to the County any information necessary to maintain the certification's accuracy.

- (c) <u>Records Access.</u> The parties acknowledge and agree that all records, information, and data ("<u>Information</u>") acquired in connection with performance or administration of this Agreement shall be used and disclosed solely for the purpose of performance and administration of the contract or as required by law. The Contractor acknowledges that the Contractor Information in the County's possession may be subject to disclosure under Article 6 of the New York State Public Officer's Law ("Freedom of Information Law" or "FOIL"). In the event that such a request for disclosure is made, the County shall make reasonable efforts to notify the Contractor of such request prior to disclosure of the Information so that the Contractor may take such action as it deems appropriate.
- (d) <u>Protection of Client Information</u>. The Contractor acknowledges and agrees that all information that the Contractor acquires in connection with performance under this Agreement is strictly confidential, shall be held in the strictest confidence and shall be used solely for the purpose of performing services for or on behalf of the County. Such confidential information shall not be disclosed to third parties except (i) as permitted under this Agreement, or (ii) in accordance with Law or (iii) upon legal compulsion. The provisions of this Section shall survive the termination of this Agreement and any breach of these provisions shall be cause for immediate termination of this Agreement.
- 7. Minimum Service Standards. Regardless of whether required by Law: (a) The Contractor shall, and shall cause Contractor Agents to, conduct its, his or her activities in connection with this Agreement so as not to endanger or harm any Person or property.
- (b) The Contractor shall deliver services under this Agreement in a professional manner consistent with the best practices of the industry in which the Contractor operates. The Contractor shall take all actions necessary or appropriate to meet the obligation described in the immediately preceding sentence, including obtaining and maintaining, and causing all Contractor Agents to obtain and maintain, all approvals, licenses, and certifications ("Approvals") necessary or appropriate in connection with this Agreement.
- 8. Indemnification; Defense: Cooperation. (a) The Contractor shall be solely responsible for and shall indemnify and hold harmless the County, the Department and its officers. employees, and agents (the "Indemnified Parties") from and against any and all liabilities, losses, costs, expenses (including, without limitation, attorneys' fees and disbursements) and damages ("Losses"), arising out of or in connection with any acts or omissions of the Contractor or a Contractor Agent, regardless of whether due to negligence, fault, or default, including Losses in connection with any threatened investigation, litigation or other proceeding or preparing a defense to or prosecuting the same; provided, however, that the Contractor shall not be responsible for that portion, if any, of a Loss that is caused by the negligence of the County.
- (b) The Contractor shall, upon the County's demand and at the County's direction, promptly and diligently defend, at the Contractor's own risk and expense, any and all suits, actions, or proceedings which may be brought or instituted against one or more Indemnified Parties for which

the Contractor is responsible under this Section, and, further to the Contractor's indemnification obligations, the Contractor shall pay and satisfy any judgment, decree, loss or settlement in connection therewith.

- (c) The Contractor shall, and shall cause Contractor Agents to, cooperate with the County and the Department in connection with the investigation, defense or prosecution of any action, suit or proceeding in connection with this Agreement, including the acts or omissions of the Contractor and/or a Contractor Agent in connection with this Agreement.
 - (d) The provisions of this Section shall survive the termination of this Agreement.
- 9. Insurance. (a) Types and Amounts. The Contractor shall obtain and maintain throughout the term of this Agreement, at its own expense: (i) one or more policies for commercial general liability insurance, which policy(ies) shall name "Nassau County" as an additional insured and have a minimum single combined limit of liability of not less than one million dollars (\$1,000,000) per claim and two million dollars (\$2,000,000) aggregate coverage, (ii) if contracting in whole or part to provide professional services, one or more policies for professional liability insurance, which policy(ies) shall have a minimum single combined limit liability of not less than one million dollars (\$1,000,000) per claim, (iii) compensation insurance for the benefit of the Contractor's employees ("Workers' Compensation Insurance"), which insurance is in compliance with the New York State Workers' Compensation Law, and (iv) such additional insurance as the County may from time to time specify.
- (b) Acceptability: Deductibles; Subcontractors. All insurance obtained and maintained by the Contractor pursuant to this Agreement shall be (i) written by one or more commercial insurance carriers licensed to do business in New York State and acceptable to the County, and which is (ii) in form and substance acceptable to the County. The Contractor shall be solely responsible for the payment of all deductibles to which such policies are subject. The Contractor shall require any subcontractor hired in connection with this Agreement to carry insurance with the same limits and provisions required to be carried by the Contractor under this Agreement.
- (c) <u>Delivery; Coverage Change; No Inconsistent Action</u>. Prior to the execution of this Agreement, copies of current certificates of insurance evidencing the insurance coverage required by this Agreement shall be delivered to the Department. Not less than thirty (30) days prior to the date of any expiration or renewal of, or actual, proposed or threatened reduction or cancellation of coverage under, any insurance required hereunder, the Contractor shall provide written notice to the Department of the same and deliver to the Department renewal or replacement certificates of insurance. The Contractor shall cause all insurance to remain in full force and effect throughout the term of this Agreement and shall not take or omit to take any action that would suspend or invalidate any of the required coverage. The failure of the Contractor to maintain Workers' Compensation Insurance shall render this contract void and of no effect. The failure of the Contractor to maintain the other required coverage shall be deemed a material breach of this Agreement upon which the County reserves the right to consider this Agreement terminated as of the date of such failure.

- the rights and obligations hereunder may not be in whole or part (i) assigned, transferred or disposed of, (ii) amended, (iii) waived, or (iv) subcontracted, without the prior written consent of the County Executive or his or her duly designated deputy (the "County Executive"), and any purported assignment, other disposal or modification without such prior written consent shall be null and void. The failure of a party to assert any of its rights under this Agreement, including the right to demand strict performance, shall not constitute a waiver of such rights.
- 11. <u>Termination</u>. (a) <u>Generally</u>. This Agreement may be terminated (i) for any reason by the County upon thirty (30) days' written notice to the Contractor, (ii) for "Cause" by the County immediately upon the receipt by the Contractor of written notice of termination, (iii) upon mutual written Agreement of the County and the Contractor, and (iv) in accordance with any other provisions of this Agreement expressly addressing termination.

As used in this Agreement the word "Cause" includes: (i) a breach of this Agreement; (ii) the failure to obtain and maintain in full force and effect all Approvals required for the services described in this Agreement to be legally and professionally rendered; and (iii) the termination or impending termination of federal or state funding for the services to be provided under this Agreement.

- (b) By the Contractor. This Agreement may be terminated by the Contractor if performance becomes impracticable through no fault of the Contractor, where the impracticability relates to the Contractor's ability to perform its obligations and not to a judgment as to convenience or the desirability of continued performance. Termination under this subsection shall be effected by the Contractor delivering to the commissioner or other head of the Department (the "Commissioner"), at least sixty (60) days prior to the termination date (or a shorter period if sixty days' notice is impossible), a notice stating (i) that the Contractor is terminating this Agreement in accordance with this subsection, (ii) the date as of which this Agreement will terminate, and (iii) the facts giving rise to the Contractor's right to terminate under this subsection. A copy of the notice given to the Commissioner shall be given to the Deputy County Executive who oversees the administration of the Department (the "Applicable DCE") on the same day that notice is given to the Commissioner.
- (c) <u>Contractor Assistance upon Termination</u>. In connection with the termination or impending termination of this Agreement the Contractor shall, regardless of the reason for termination, take all actions reasonably requested by the County (including those set forth in other provisions of this Agreement) to assist the County in transitioning the Contractor's responsibilities under this Agreement. The provisions of this subsection shall survive the termination of this Agreement.
- 12. Accounting Procedures: Records. The Contractor shall maintain and retain, for a period of six (6) years following the later of termination of or final payment under this Agreement, complete and accurate records, documents, accounts and other evidence, whether maintained electronically or manually ("Records"), pertinent to performance under this Agreement. Records shall be maintained in accordance with Generally Accepted Accounting Principles and, if the Contractor is a non-profit entity, must comply with the accounting guidelines set forth in the federal Office of Management & Budget Circular A-122, "Cost Principles for Non-Profit Organizations." Such Records shall at all times be available for audit and inspection by the

Comptroller, the Department, any other governmental authority with jurisdiction over the provision of services hereunder and/or the payment therefore, and any of their duly designated representatives. The provisions of this Section shall survive the termination of this Agreement.

- 13. <u>Limitations on Actions and Special Proceedings against the County.</u> No action or special proceeding shall lie or be prosecuted or maintained against the County upon any claims arising out of or in connection with this Agreement unless:
- (a) Notice. At least thirty (30) days prior to seeking relief the Contractor shall have presented the demand or claim(s) upon which such action or special proceeding is based in writing to the Applicable DCE for adjustment and the County shall have neglected or refused to make an adjustment or payment on the demand or claim for thirty (30) days after presentment. The Contractor shall send or deliver copies of the documents presented to the Applicable DCE under this Section to each of (i) the Department and the (ii) the County Attorney (at the address specified above for the County) on the same day that documents are sent or delivered to the Applicable DCE. The complaint or necessary moving papers of the Contractor shall allege that the above-described actions and inactions preceded the Contractor's action or special proceeding against the County.
- (b) <u>Time Limitation</u>. Such action or special proceeding is commenced within the earlier of (i) one (1) year of the first to occur of (A) final payment under or the termination of this Agreement, and (B) the accrual of the cause of action, and (ii) the time specified in any other provision of this Agreement.
- 14. Work Performance Liability. The Contractor is and shall remain primarily liable for the successful completion of all work in accordance this Agreement irrespective of whether the Contractor is using a Contractor Agent to perform some or all of the work contemplated by this Agreement, and irrespective of whether the use of such Contractor Agent has been approved by the County.
- specified in this Agreement or required by Law, exclusive original jurisdiction for all claims or actions with respect to this Agreement shall be in the Supreme Court in Nassau County in New York State and the parties expressly waive any objections to the same on any grounds, including venue and forum non conveniens. This Agreement is intended as a contract under, and shall be governed and construed in accordance with, the Laws of New York State, without regard to the conflict of laws provisions thereof.
- 16. Notices. Any notice, request, demand or other communication required to be given or made in connection with this Agreement shall be (a) in writing, (b) delivered or sent (i) by hand delivery, evidenced by a signed, dated receipt, (ii) postage prepaid via certified mail, return receipt requested, or (iii) overnight delivery via a nationally recognized courier service. (c) deemed given or made on the date the delivery receipt was signed by a County employee, three (3) business days after it is mailed or one (1) business day after it is released to a courier service, as applicable, and (d)(i) if to the Department, to the attention of the Commissioner at the address specified above for the Department, (ii) if to an Applicable DCE, to the attention of the Applicable DCE (whose name the Contractor shall obtain from the Department) at the address specified above for the

- County, (<u>iii</u>) if to the Comptroller, to the attention of the Comptroller at 240 Old Country Road, Mineola, NY 11501, and (<u>iv</u>) if to the Contractor, to the attention of the person who executed this Agreement on behalf of the Contractor at the address specified above for the Contractor, or in each case to such other persons or addresses as shall be designated by written notice.
- 17. All Legal Provisions Deemed Included; Severability; Supremacy. (a) Every provision required by Law to be inserted into or referenced by this Agreement is intended to be a part of this Agreement. If any such provision is not inserted or referenced or is not inserted or referenced in correct form then (i) such provision shall be deemed inserted into or referenced by this Agreement for purposes of interpretation and (ii) upon the application of either party this Agreement shall be formally amended to comply strictly with the Law, without prejudice to the rights of either party.
- (b) In the event that any provision of this Agreement shall be held to be invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions shall not in any way be affected or impaired thereby.
- (c) Unless the application of this subsection will cause a provision required by Law to be excluded from this Agreement, in the event of an actual conflict between the terms and conditions set forth above the signature page to this Agreement and those contained in any schedule, exhibit, appendix, or attachment to this Agreement, the terms and conditions set forth above the signature page shall control. To the extent possible, all the terms of this Agreement should be read together as not conflicting.
- (d) Each party has cooperated in the negotiation and preparation of this Agreement. Therefore, in the event that construction of this Agreement occurs, it shall not be construed against either party as drafter.
- 18. Section and Other Headings. The section and other headings contained in this Agreement are for reference purposes only and shall not affect the meaning or interpretation of this Agreement.
- 19. Entire Agreement. This Agreement represents the full and entire understanding and agreement between the parties with regard to the subject matter hereof and supersedes all prior agreements (whether written or oral) of the parties relating to the subject matter of this Agreement.
 - **Executory Clause.** Notwithstanding any other provision of this Agreement:
- (a) Approval and Execution. The County shall have no liability under this Agreement (including any extension or other modification of this Agreement) to any Person unless (i) all County and other governmental approvals have been obtained, including, if required, approval by the County Legislature, and (ii) this Agreement has been executed by the County Executive (as defined in this Agreement).
- (b) Availability of Funds. The County shall have no liability under this Agreement (including any extension or other modification of this Agreement) to any Person beyond funds

appropriated or otherwise lawfully available for this Agreement, and, if any portion of the funds for this Agreement are from the state and/or federal governments, then beyond funds available to the County from the state and/or federal governments.

APPENDIX A BUDGET AND SCOPE OF SERVICES (p. 4)

The Contractor shall provide human resources and payroll management functions for the staff hired pursuant to the terms of this Agreement (collectively known as "Contract Staff").

Complete job descriptions for Contract Staff shall be provided by the Department. Contract staff will be physically situated at locations provided and/or determined by the Department and the Department will provide all necessary furniture, office equipment and supplies, as required by Contract Staff to perform their jobs. Further, the Department shall be responsible for supervising and evaluating the job performance of all Contract Staff.

Compensation and Benefits

All Contract Staff will be paid according to the terms of the budget set forth in Appendix A of the Agreement. With the exception of the <u>full-time</u> Re-Entry Case Managers, all Contract Staff covered by this Agreement shall not work more than 18 hours per week and, therefore, shall not be eligible for any paid time off or other FCA employee benefits, other than those mandated by applicable by law.

The <u>full-time Re-Entry Case Managers</u> shall be entitled to paid time off and other benefits on a calendar year basis as follows:

- 13 paid holidays. In accordance with the Contractor's policies for other employees, the full-time Re-Entry Case Managers will be paid for the following holidays per calendar year: New Year's Day, Martin Luther King's Birthday, Presidents Day, Memorial Day, Fourth of July, Labor Day, Columbus Day, Veterans Day, Thanksgiving Day, Day after Thanksgiving, Christmas Day and two (2) floating holidays.
- 12 paid sick days. In accordance with the Contractor's policies for other employees, the
 full-time Re-Entry Case Managers may accrue and carry over from year to year a maximum
 of 65 days, but will not be paid for accrued, unused sick leave upon the termination of
 employment for any reason.
- 20 paid vacation days. The full-time Re-Entry Case Managers will be entitled to carry over a maximum of ten (10) accrued, unused vacation days each year. The full-time Re-Entry Case Managers, however, will not be paid for accrued, unused vacation time upon the termination of employment for any reason.
- 4 personal days. In accordance with the Contractor's policies for other employees, the full-time Re-Entry Case Managers may not accrue and carry over personal days. Further, the full-time Re-Entry Case Managers will not be paid for accrued, unused personal time upon the termination of employment for any reason.

APPENDIX A BUDGET AND SCOPE OF SERVICES (p. 5)

- 3 bereavement leave days. In accordance with the Contractor's policies for other employees, the full-time Re-Entry Case Managers will be granted three (3) days off with pay in the event of the death of a member of their immediate family and, for relatives not in their immediate family, one day off.
- Ten paid days for jury duty. In accordance with the Contractor's policies for other employees, the full-time Re-Entry Case Managers will be paid for the first ten days of active jury duty.
- The full-time Re-Entry Case Managers may elect to participate in the Contractor's health insurance plans subject to their payment of the cost shares applicable to the Contractor's other eligible employees. For those electing to participate, the County shall reimburse the Contractor for 100% of the Contractor's portion of the premium, payable out of the Fringe Benefits budget line provided in Appendix A of this Agreement.

Contract staff will have access to the Contractor's electronic timekeeping system, Time Force, and will be required to clock in and out of work, request and record all absences, and verify their time cards via this system. The Department will be responsible for reviewing and verifying the time cards and approving the Contract Staff's requests for time off where allowed. Contract Staff will be required to print out paper copies of their bi-weekly time cards to be reviewed and signed by a representative of the Department. These signed time cards will be forwarded to the Contractor's Payroll Administrator on a monthly basis for recordkeeping purposes. Scheduled time off, where allowed, will be at the discretion of the Department, however, approval of time off by the Department will not add to the paid time off provided for by the Contractor.

Employment-Related Policies and Procedures

The Contractor shall be responsible for the development and implementation of all appropriate employment-related policies and protocols for Contract Staff.

APPENDIX EE Equal Employment Opportunities for Minorities and Women

The provisions of this Appendix EE are hereby made a part of the document to which it is attached.

The Contractor shall comply with all federal, State and local statutory and constitutional antidiscrimination provisions. In addition, Local Law No. 14-2002, entitled "Participation by Minority Group Members and Women in Nassau County Contracts," governs all County Contracts as defined herein and solicitations for bids or proposals for County Contracts. In accordance with Local Law 14-2002:

- (a) The Contractor shall not discriminate against employees or applicants for employment because of race, creed, color, national origin, sex, age, disability or marital status in recruitment, employment, job assignments, promotions, upgradings, demotions, transfers, layoffs, terminations, and rates of pay or other forms of compensation. The Contractor will undertake or continue existing programs related to recruitment, employment, job assignments, promotions, upgradings, transfers, and rates of pay or other forms of compensation to ensure that minority group members and women are afforded equal employment opportunities without discrimination.
- (b) At the request of the County contracting agency, the Contractor shall request each employment agency, labor union, or authorized representative of workers with which it has a collective bargaining or other agreement or understanding, to furnish a written statement that such employment agency, union, or representative will not discriminate on the basis of race, creed, color, national origin, sex, age, disability, or marital status and that such employment agency, labor union, or representative will affirmatively cooperate in the implementation of the Contractor's obligations herein.
- (c) The Contractor shall state, in all solicitations or advertisements for employees, that, in the performance of the County Contract, all qualified applicants will be afforded equal employment opportunities without discrimination because of race, creed, color, national origin, sex, age, disability or marital status.
- (d) The Contractor shall make best efforts to solicit active participation by certified minority or women-owned business enterprises ("Certified M/WBEs") as defined in Section 101 of Local Law No. 14-2002, for the purpose of granting of Subcontracts.
- (e) The Contractor shall, in its advertisements and solicitations for Subcontractors, indicate its interest in receiving bids from Certified M/WBEs and the requirement that Subcontractors must be equal opportunity employers.
- (f) Contractors must notify and receive approval from the respective Department Head prior to issuing any Subcontracts and, at the time of requesting such authorization, must submit a signed Best Efforts Checklist.

- (g) Contractors for projects under the supervision of the County's Department of Public Works shall also submit a utilization plan listing all proposed Subcontractors so that, to the greatest extent feasible, all Subcontractors will be approved prior to commencement of work. Any additions or changes to the list of subcontractors under the utilization plan shall be approved by the Commissioner of the Department of Public Works when made. A copy of the utilization plan any additions or changes thereto shall be submitted by the Contractor to the Office of Minority Affairs simultaneously with the submission to the Department of Public Works.
- (h) At any time after Subcontractor approval has been requested and prior to being granted, the contracting agency may require the Contractor to submit Documentation Demonstrating Best Efforts to Obtain Certified Minority or Women-owned Business Enterprises. In addition, the contracting agency may require the Contractor to submit such documentation at any time after Subcontractor approval when the contracting agency has reasonable cause to believe that the existing Best Efforts Checklist may be inaccurate. Within ten working days (10) of any such request by the contracting agency, the Contractor must submit Documentation.
- (i) In the case where a request is made by the contracting agency or a Deputy County Executive acting on behalf of the contracting agency, the Contractor must, within two (2) working days of such request, submit evidence to demonstrate that it employed Best Efforts to obtain Certified M/WBE participation through proper documentation.
- (j) Award of a County Contract alone shall not be deemed or interpreted as approval of all Contractor's Subcontracts and Contractor's fulfillment of Best Efforts to obtain participation by Certified M/WBEs.
- (k) A Contractor shall maintain Documentation Demonstrating Best Efforts to Obtain Certified Minority or Women-owned Business Enterprises for a period of six (6) years. Failure to maintain such records shall be deemed failure to make Best Efforts to comply with this Appendix EE, evidence of false certification as M/WBE compliant or considered breach of the County Contract.
- (l) The Contractor shall be bound by the provisions of Section 109 of Local Law No. 14-2002 providing for enforcement of violations as follows:
 - a. Upon receipt by the Executive Director of a complaint from a contracting agency that a County Contractor has failed to comply with the provisions of Local Law No. 14-2002, this Appendix EE or any other contractual provisions included in furtherance of Local Law No. 14-2002, the Executive Director will try to resolve the matter.
 - b. If efforts to resolve such matter to the satisfaction of all parties are unsuccessful, the Executive Director shall refer the matter, within thirty days (30) of receipt of the complaint, to the American Arbitration Association for proceeding thereon.
 - c. Upon conclusion of the arbitration proceedings, the arbitrator shall submit to the Executive Director his recommendations regarding the imposition of sanctions,

fines or penalties. The Executive Director shall either (i) adopt the recommendation of the arbitrator (ii) determine that no sanctions, fines or penalties should be imposed or (iii) modify the recommendation of the arbitrator, provided that such modification shall not expand upon any sanction recommended or impose any new sanction, or increase the amount of any recommended fine or penalty. The Executive Director, within ten days (10) of receipt of the arbitrators award and recommendations, shall file a determination of such matter and shall cause a copy of such determination to be served upon the respondent by personal service or by certified mail return receipt requested. The award of the arbitrator, and the fines and penalties imposed by the Executive Director, shall be final determinations and may only be vacated or modified as provided in the civil practice law and rules ("CPLR").

(m) The contractor shall provide contracting agency with information regarding all subcontracts awarded under any County Contract, including the amount of compensation paid to each Subcontractor and shall complete all forms provided by the Executive Director or the Department Head relating to subcontractor utilization and efforts to obtain M/WBE participation.

Failure to comply with provisions (a) through (m) above, as ultimately determined by the Executive Director, shall be a material breach of the contract constituting grounds for immediate termination. Once a final determination of failure to comply has been reached by the Executive Director, the determination of whether to terminate a contract shall rest with the Deputy County Executive with oversight responsibility for the contracting agency.

Provisions (a), (b) and (c) shall not be binding upon Contractors or Subcontractors in the performance of work or the provision of services or any other activity that are unrelated, separate, or distinct from the County Contract as expressed by its terms.

The requirements of the provisions (a), (b) and (c) shall not apply to any employment or application for employment outside of this County or solicitations or advertisements therefor or any existing programs of affirmative action regarding employment outside of this County and the effect of contract provisions required by these provisions (a), (b) and (c) shall be so limited.

The Contractor shall include provisions (a), (b) and (c) in every Subcontract in such a manner that these provisions shall be binding upon each Subcontractor as to work in connection with the County Contract.

As used in this Appendix EE the term "Best Efforts Checklist" shall mean a list signed by the Contractor, listing the procedures it has undertaken to procure Subcontractors in accordance with this Appendix EE.

As used in this Appendix EE the term "County Contract" shall mean (i) a written agreement or purchase order instrument, providing for a total expenditure in excess of twenty-five thousand dollars (\$25,000), whereby a County contracting agency is committed to expend or does expend funds in return for labor, services, supplies, equipment, materials or any combination of the

foregoing, to be performed for, or rendered or furnished to the County; or (ii) a written agreement in excess of one hundred thousand dollars (\$100,000), whereby a County contracting agency is committed to expend or does expend funds for the acquisition, construction, demolition, replacement, major repair or renovation of real property and improvements thereon. However, the term "County Contract" does not include agreements or orders for the following services: banking services, insurance policies or contracts, or contracts with a County contracting agency for the sale of bonds, notes or other securities.

As used in this Appendix EE the term "County Contractor" means an individual, business enterprise, including sole proprietorship, partnership, corporation, not-for-profit corporation, or any other person or entity other than the County, whether a contractor, licensor, licensee or any other party, that is (i) a party to a County Contract, (ii) a bidder in connection with the award of a County Contract, or (iii) a proposed party to a County Contract, but shall not include any Subcontractor.

As used in this Appendix EE the term "County Contractor" shall mean a person or firm who will manage and be responsible for an entire contracted project.

As used in this Appendix EE "Documentation Demonstrating Best Efforts to Obtain Certified Minority or Women-owned Business Enterprises" shall include, but is not limited to the following:

- a. Proof of having advertised for bids, where appropriate, in minority publications, trade newspapers/notices and magazines, trade and union publications, and publications of general circulation in Nassau County and surrounding areas or having verbally solicited M/WBEs whom the County Contractor reasonably believed might have the qualifications to do the work. A copy of the advertisement, if used, shall be included to demonstrate that it contained language indicating that the County Contractor welcomed bids and quotes from M/WBE Subcontractors. In addition, proof of the date(s) any such advertisements appeared must be included in the Best Effort Documentation. If verbal solicitation is used, a County Contractor's affidavit with a notary's signature and stamp shall be required as part of the documentation.
- b. Proof of having provided reasonable time for M/WBE Subcontractors to respond to bid opportunities according to industry norms and standards. A chart outlining the schedule/time frame used to obtain bids from M/WBEs is suggested to be included with the Best Effort Documentation
- c. Proof or affidavit of follow-up of telephone calls with potential M/WBE subcontractors encouraging their participation. Telephone logs indicating such action can be included with the Best Effort Documentation
- d. Proof or affidavit that M/WBE Subcontractors were allowed to review bid specifications, blue prints and all other bid/RFP related items at no charge to the M/WBEs, other than reasonable documentation costs incurred by the County Contractor that are passed onto the M/WBE.

- e. Proof or affidavit that sufficient time prior to making award was allowed for M/WBEs to participate effectively, to the extent practicable given the timeframe of the County Contract.
- f. Proof or affidavit that negotiations were held in good faith with interested M/WBEs, and that M/WBEs were not rejected as unqualified or unacceptable without sound business reasons based on (1) a thorough investigation of M/WBE qualifications and capabilities reviewed against industry custom and standards and (2) cost of performance The basis for rejecting any M/WBE deemed unqualified by the County Contractor shall be included in the Best Effort Documentation
- g. If an M/WBE is rejected based on cost, the County Contractor must submit a list of all sub-bidders for each item of work solicited and their bid prices for the work.
- h. The conditions of performance expected of Subcontractors by the County Contractor must also be included with the Best Effort Documentation
- County Contractors may include any other type of documentation they feel necessary to further demonstrate their Best Efforts regarding their bid documents.

As used in this Appendix EE the term "Executive Director" shall mean the Executive Director of the Nassau County Office of Minority Affairs; provided, however, that Executive Director shall include a designee of the Executive Director except in the case of final determinations issued pursuant to Section (a) through (l) of these rules.

As used in this Appendix EE the term "Subcontract" shall mean an agreement consisting of part or parts of the contracted work of the County Contractor.

As used in this Appendix EE, the term "Subcontractor" shall mean a person or firm who performs part or parts of the contracted work of a prime contractor providing services, including construction services, to the County pursuant to a county contract. Subcontractor shall include a person or firm that provides labor, professional or other services, materials or supplies to a prime contractor that are necessary for the prime contractor to fulfill its obligations to provide services to the County pursuant to a county contract. Subcontractor shall not include a supplier of materials to a contractor who has contracted to provide goods but no services to the County, nor a supplier of incidental materials to a contractor, such as office supplies, tools and other items of nominal cost that are utilized in the performance of a service contract.

Provisions requiring contractors to retain or submit documentation of best efforts to utilize certified subcontractors and requiring Department head approval prior to subcontracting shall not apply to inter-governmental agreements. In addition, the tracking of expenditures of County dollars by not-for-profit corporations, other municipalities, States, or the federal government is not required.
