- All Forms 1095-Health Ins. Statements
- Information for credits that you are claiming (Student loan interest, Education credit)

- Social Security card (or ITIN) for you, your spouse and dependents
- Birth dates for you, your spouse and dependents on the tax return
- To file taxes electronically on a married-filing-joint tax return, both spouses must be present to sign the required forms.
- Other applicable tax-related documents, such as: interest statements, federal loan documents, retirement statements, list of organizations to which you made charitable donations, etc.
- Total paid for daycare provider and the daycare provider's tax identifying number such as their Social Security number or business Employer Identification Number
- Blank check (to verify direct deposit information to your refund)

Who Is Eligible to Attend this Event:

- Veterans of all eras and their spouses are welcome
- Spouse of a Fallen Servicemember and their children
- Income less than \$90,000

AARP Cannot Prepare:

- Schedule C if expenses exceed \$25,000
- Complicated Schedule D (Capital Gains and Losses) without Proper Paperwork
- Schedule E (Rental Property) with expenses, including depreciation (exception: returns for military members only, prepared by a counselor who has been certified to do military returns provided another military certified counselor is available to quality review the return)
- Schedule F (Farm Income)
- 2106 (employee Business Expenses)
- 3903 (Moving Expenses)
- 8615 (Minor's Investment Income)
- Portions of Schedules A and B that are not included in our training
- Schedule K-I that involves depreciation or deductible expenses
- Other rental income or business income
