# **COUNTY ATTORNEY INTERNSHIP OPPORTUNITIES**

The Office of the Nassau County Attorney welcomes law students (including a limited number of undergraduate and high school students with a demonstrated interest in the law) to our Spring, Fall and Summer legal internship semesters to work in our various bureaus. Our goal is to provide interns with a diverse experience through our one-on-one supervision approach from one of our deputy county attorneys. We strive to offer interns opportunities to assist in researching and writing memorandums, motions and briefs, proposed legislation and legal opinions. Students are provided the opportunity to participate in depositions and observe court matters and are exposed to the management of legal files and insight into the ethical obligations of our profession. In addition, law students have the opportunity to work with our deputy county attorneys in the preparation of litigation strategy and practice.

## **Litigation: Federal and State Courts**

The Office of the Nassau County Attorney handles diverse litigation in federal and state court. Our caseload includes federal civil rights and discrimination cases and state court tort, tax certiorari, commercial and environmental matters. Our office defends the County in personal injury and negligence cases and discrimination, employment and labor law claims at administrative hearings as well as in court. When appropriate, the office brings affirmative litigation on behalf of Nassau County.

## **Property Assessment Litigation Bureau**

Our Property Assessment Litigation Bureau handles real property tax review cases, tax exemption issues, and condemnation proceedings and acquisitions of property.

#### Appeals

Our office represents Nassau County in all aspects of state and federal appellate practice.

### Legal Counsel

Deputy county attorneys in Legal Counsel draft local legislation, respond to proposed state legislation and provide legal opinions on a regular basis to all of Nassau County's agencies.

## **Family Court**

In Family Court, our deputy county attorneys represent the County in child abuse and neglect, child support actions, and investigation and prosecution of juveniles. Working in tandem with Nassau County's Department of Social Services (NCDSS), deputy county attorneys prepare Family Court Act Article 10 child abuse and neglect petitions, petitions for the removal of children and petitions for modification, extension or violation of existing court orders, and, if necessary, petitions for the termination of parental rights for filing in Nassau County Family Court. In addition, NCDSS and Family Court deputy county attorneys establish and enforce child support orders on behalf of out-of-state custodial parents and their children and on behalf of NCDSS in order to recoup public assistance to offset public assistance grants given to custodial parents.

## **Municipal Transactions and Real Estate**

The Office handles a wide range of transactional matters. The Municipal Transactions Bureau represents the County on a broad range of contractual and real estate matters, including leases, use and occupancy agreements, real estate closings and day-to-day advice.
