#### ORDINANCE NO. 47 - 2020

## AN ORDINANCE TO AMEND ORDINANCE NO. 180-2016 ENTITLED "AN ORDINANCE ESTABLISHING A FEE SCHEDULE FOR COUNTY SERVICES FOR VARIOUS COUNTY DEPARTMENTS" PURSUANT TO THE COUNTY GOVERNMENT LAW OF NASSAU COUNTY AND THE NASSAU COUNTY ADMINISTRATIVE CODE

WHEREAS, pursuant to section 10(1)(ii)(a)(9-a) of the Municipal Home Rule Law, the County of Nassau has the power to adopt and amend legislation relating to the fixing, levy, collection and administration of charges, fees and penalties; and

WHEREAS, Ordinance 180-2016 establishes a fee schedule for county services for various County departments including a listing fee imposed as penalty on delinquent property tax payments; and

WHEREAS, the closure of all businesses deemed non-essential by the State of New York due to the COVID-19 pandemic has, <u>inter alia</u>, caused a dramatic rise in unemployment and underemployment in the downstate region, resulting in widespread termination of or reduction in income for many Nassau County residential taxpayers; and

WHEREAS, in the judgement of this Legislature, it is necessary and proper to afford some measure of economic relief to such taxpayers who, due to the financial hardship created by COVID-19, are unable to pay their property taxes in a timely fashion; and

WHEREAS, this Legislature accordingly deems it appropriate to waive the listing fee tax penalty imposed upon class one and class two residential properties: NOW THEREFORE

BE IT ORDAINED by the County Legislature as follows: **Section 1.** Section 4 of Ordinance No. 180-2016 is amended to read as follows:

§4. The following fees are set or authorized and set for the County Treasurer for the following years.

Notwithstanding the forgoing, listing fee tax penalties authorized and set by this section in connection with the delinquent payment of property taxes shall be waived for the year 2020 with respect to property classified as class one or class two pursuant to section 1802(1) of the Real Property Tax Law. The foregoing waiver shall not apply to listing fee tax penalties paid prior to May 18, 2020.

**Section 2. Severability.** If any clause, sentence, paragraph, subdivision, section, or part of this law or the application thereof to any person, individual, corporation, firm, partnership, entity, or circumstance shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section or part of this law, or in its application to the person, individual, corporation, firm, partnership, entity, or circumstance directly involved in the controversy in which such order or judgment shall be rendered.

**Section 3. SEQRA Determination.** It is hereby determined, pursuant to the provisions of the State Environmental Quality Review Act, 8 N.Y.E.C.L., section 0101 et seq. and its implementing regulations, Part 617 of 6 N.Y.C.R.R. and section 1611 of the County Government Law of Nassau County, that the adoption of this ordinance is a "Type II" Action within the meaning of Sections 617.5(c)(26) and (33) of 6 N.Y.C.R.R., and, accordingly, is of a class of actions which do not have a significant effect on the environment; and no further review is required.

Section 4. This ordinance shall take effect immediately upon final adoption.

#### ORDINANCE NO. 48-2020

### AN ORDINANCE TO TEMPORARILY RESTRICT ATTENDANCE AT NICKERSON BEACH TO NASSAU COUNTY RESIDENTS ONLY AND SUNSETTING SUCH RESTRICTION UPON THE REOPENING OF NEW YORK CITY OWNED AND OPERATED BEACHES

WHEREAS, Nassau County announced that as permitted by New York State and subject to strict social distancing and density guidelines, Nickerson Beach will be open Friday, May 22<sup>nd</sup> and throughout the Memorial Day weekend and thereafter; and

WHEREAS, New York City Mayor Bill de Blasio has announced that ocean access at

New York City beaches will be prohibited to its eight million residents during this time period; and

WHEREAS, Nassau County borders New York City to its east, and as a result of the City beach restrictions, a potential influx of additional beachgoers from New York City threatens to overwhelm the safe operational capacity at Nickerson Beach and crowd out access to Nassau County residents; and

WHEREAS, this potential influx of additional beachgoers may negatively impact the Nassau County residents, as vehicular and pedestrian traffic will overload roadways, preventing residents and first responders from navigating the County freely and prevent Nassau residents from accessing Nickerson Beach; and

WHEREAS, as a result of New York City's beach restrictions and its resulting negative impact on Nassau County, it is necessary for the Nassau County Legislature to allow only Nassau County residents to visit Nickerson Beach; and

WHEREAS, this action is necessary to protect the health, safety and welfare of Nassau County residents; NOW THEREFORE BE IT ORDAINED by the County Legislature of the County of Nassau as follows:

Section 1. Notwithstanding any other law or rule, in order to protect Nassau County residents, access to Nickerson Beach shall be restricted to Nassau County residents only. This Ordinance shall cease to have any effect upon the restoration of resident and nonresident access to New York City beaches consistent with the minimum standards set by New York State.

§2. It is hereby determined by the Nassau County Legislature, the lead agency, and pursuant to the provisions of the State Environmental Quality Review Act ("SEQRA"), 8 NYECL section 0101 et seq. and its implementing regulations, Part 617 of 6 NYCRR, and Section 1611 of the County Government Law of Nassau County, that this Ordinance will not have a significant impact on the environment and that no further environmental review or action is required.

§3. This ordinance shall take effect immediately.

There's no reason to 7 call a new meeting. Just note on the record 8 that we have not received any public comment 9 about this emergency. There's no requirement 10 in a recessed meeting to call the roll. What 11 I'm going to do is when I call the emergency 12 I'm going to call the roll so that we know who 13 is actually voting and who is present 14 remotely.

15 First item of business is to 16 establish an emergency for an ordinance to 17 temporarily restrict attendance at Nickerson 18 Beach to Nassau County residents only and 19 sunsetting such restriction upon the reopening 20 of New York City owned and operated beaches. 21 Moved by Legislator Ferretti. 22 Seconded by Legislator Rhoads. That's to 23 establish the emergency. Any debate or 24 discussion on the emergency? Obviously the 25 emergency is that we want to get this in place

This 4 emergency measure, local law -- my 5 understanding is Legislator Solages is trying б to connect remotely and once he does we will 7 record his vote for both the emergency and the 8 item. 9 The legislation temporarily 10 restricts access to Nassau County beaches, 11 essentially Nickerson Beach, to Nassau County 12 residents only. We are taking this action in 13 conjunction with the Town of Hempstead which 14 vesterday passed a similar measure. The 15 concern here is that a small fraction of the 16 eight million New York City residents, that a 17 small fraction of those residents could come 18 to Nassau County beaches because the city 19 beaches are closed to bathing. This would 20 overwhelm our local beaches. 21 LEGISLATOR SOLAGES: Hi. This is 22 I'm having a little bit of Carrie. 23 difficulty. Is anybody there? 24 LEGISLATOR NICOLELLO: Yes, we 25 hear you. Can you hear us?

1 Full 5-20-20 2 LEGISLATOR SOLAGES: I can hear 3 you now. 4 LEGISLATOR NICOLELLO: We know 5 you're there. б The concern, as I said, is that a 7 small fraction of the eight million residents 8 of the city of New York if they attempt to 9 come to Nassau County beaches because of the 10 restrictions imposed by Mayor de Blasio would 11 overwhelm our beaches. Not only our beaches 12 but the barrier island roads that we have such 13 limitation on them. 14 Our beaches also will have limited 15 access as is directed by the state of New York 16 in conjunction with four other states who are 17 imposing similar restraints. We will have 18 half of our capacity. There will be social 19 distancing et cetera. It's safe that our 20 beaches will be opened safely. But with 21 limited capacity and the possibility of large 22 number of individuals trying to access Nassau 23 County beaches it makes for a potentially 24 chaotic and catastrophic situation. 25 This is not about any sort of issue

2 with our neighbors to the west. Once the 3 mayor opens the beaches and New York City this 4 legislation sunsets. So we anticipate that we 5 will go back to the situation which existed б forever which residents and nonresidents can 7 qo to our beaches and nonresidents will pay a 8 different fee. But again, this is about the 9 health and safety and welfare of Nassau County 10 residents. It's also making sure that Nassau 11 County residents, many of whom are not working or at home or looking for ways to go out and 12 13 recreation and enjoy the sunshine. It's a 14 concern that they will be precluded from doing 15 that.

So again, this is about the mayor's decision. Once he changes his mind and goes into compliance with the rest of the states in the northeast region and opens his beaches this measure will sunset.

21 Anyone else want to speak on the 22 item? Sure. Legislator DeRiggi-Whitton. 23 LEGISLATOR DERIGGI-WHITTON: I 24 just want to mention as far as I do agree that 25 we should reserve the places for the Nassau

Especially the parking is 3 going to be limited and everything else. 4 However, the only thing I'm worried about is 5 saying that we will have to wait until the б city opens the beaches. I don't know if they 7 were technically closed. I believe they are 8 open to walk on. The only thing I see in 9 writing is that they can't go swimming. And 10 it's 40 degrees in the water, 45. I don't 11 know. I just want to be careful with that as 12 to when we're going to lift it. Maybe we 13 should just say we're going to lift it at the 14 time when we fell the restrictions are no 15 longer necessary.

16 LEGISLATOR NICOLELLO: T think 17 that's what this legislation does and you're right, the mayor is allowing people to walk on 18 19 the beaches, take a chair and sit on the 20 beach. The 22 moment the temperature goes up to 80 or 90 23 degrees to think that the people are going to 24 go to a beach and sit there without being able 25 to go in the water it's kind of foolish.

2 Those people are going to look to go somewhere 3 else.

4 I think the mayor basically by 5 expressing concern about the fact that Long б Island is closing its beaches acknowledges 7 I think the mayor fully understands that. 8 that those people who live in the city who 9 have the means to go to the Jersey shore or to 10 the Hamptons or to Long Island beaches will do 11 Unfortunately, his decision is just so. 12 affecting those people who don't have the 13 means to do that.

Again, technically New York City beaches are not closed but in reality if you're not letting people in the water the weather goes up what use is that? It's like sending someone to the Sahara desert.
