There will be a hearing of the full legislature on December 14 th. 299-20 is a resolution declaring a capital budget emergency pursuant to Section 310 of the county government law of Nassau County.

Clerk item 300-20 is a bond ordinance providing for a capital expenditure to finance the capital projects identified herein within the county of Nassau and authorizing $\$ 23,178,000$ of bonds of the county of Nassau to finance such expenditure pursuant

to the local finance law of New York and the county government law of Nassau County.

Clerk item 301-20 is an ordinance to amend Ordinance 174-2018 as amended, adopting the capital budget for the county of Nassau for the first year of the four-year capital plan to commence on January 1, 2019, pursuant to the provisions of Section 310 of the county government law of Nassau County.

Clerk item 302-20 is a resolutions to adopt a four-year capital plan for the county of Nassau to commence on January 1, 2020 pursuant to the provisions of Section 310 of the county government law of Nassau County.

Clerk item 303-20 is an ordinance to adopt a capital budget for the county of Nassau for the first year of the four-year capital plan to commence on January 1, 2020 pursuant to the provisions of Section 310 of the county government law of Nassau County.

Clerk item 304-20, a resolution to adopt a four-year capital plan for the county of Nassau to commence on January 1, 2021 pursuant to the provisions of Section 310 of
