Camps, Groups and Organizations,

Welcome to the Nassau County Parks. We look forward to your return to the Nassau County Parks facilities for another summer season and welcome all newcomers.

It is mandatory that a **Certificate of Insurance** and **Safety Plan** be provided for each park where pools and other facilities will be or are intended to be used. The Safety Plan must include the use of your bus(es) for shelter in the event of inclement weather. Please contact the park manager at each County Park you intend to apply to in order to make requests for use of the facilities.

If your group intends to use the pools or beach, please review the mandatory "**Pool/Beach Requirements**" along with the additional services available and fees that may be imposed. It is essential that the signed agreement along with the required documents applicable to your group or situation be returned before commencing any activities. A **Safety Plan** (as stated above to include use of the buses in inclement weather), **Lifeguard/Pool Activity Leader (PAL) Certifications**, for pool or beach use, and a **Certificate of Insurance** are mandatory before any group is permitted to use the facilities at any of the parks.

Swimming pools are available at: Cantiague Park; Christopher Morley Park; North Woodmere Park; and Wantagh Park; and the beach is available at Nickerson Beach Park. Use of the pool slides at Cantiague Park, North Woodmere Park and Wantagh Park are included in the fees. As stated above, please contact the Park Managers directly in order to make arrangements for use of the facilities at each location.

**Please Note** the requirements for use of the facilities, including but not limited to, Field and Picnic area usage and applicable fees for Proprietary Groups and Not-for-Profit Groups when planning your use of the facilities. Proof of 501(c)(3) status is required and must be provided by all Not-For-Profit Groups.

## Pool, Beach & Facility Use Requirements for Camps, Groups & Organizations

All camps and organized groups, including, but not limited to, Day Camps, Church Groups and Daycare Camps, using the Nassau County pool and beach facilities will be required to adhere strictly to the following requirements for use of the pools and beaches located at Cantiague Park, Christopher Morley Park, Nickerson Beach Park, North Woodmere Park & Wantagh Park:

A **Safety Plan** must be provided to the Park Managers before your camp/groups commence use of the facilities. Buses transporting children to the facility must be included in the Safety Plan for use as shelter in inclement weather and will be required to remain at the park throughout the duration of the camp/groups visit. Campers will not be allowed to remain in locker rooms, lobbies or overhangs. All campers must be moved from the pool area to the waiting bus(es). Camps/ Organizations are required to pay a fee of \$45.00 for each bus per day (\$30/day for non-profit).

All groups must also staff a **Certified Red Cross Lifeguard or Pool Activity Leader (PAL)** for every 75 campers. Additional lifeguards must be provided for campers over that number. You will be denied access if your group arrives without the required lifeguard or PAL coverage. Lifeguards must wear a T-Shirt or bathing suit identifying themselves as a lifeguard and stand at the water's edge with their camp group. All groups will be required to present a valid Lifeguard or Pool Activity Leader Certification Card and provide a copy (front and back) before entrance to use the pool facilities or beach. All counselors must accompany their groups and be present on the pool deck. The minimum counselor to child ratios shall be 1:8 for campers six years old or older and 1:6 for campers younger than six years old.

***In addition, while campers are in the water the ratio required is 1 counselor in the water for every 25 campers and additional counselors are required to be around the water's edge.***

Due to the use of the pools for swim lessons, admission to the pool will begin at 12:00 noon and users must depart the facility at 3:00PM. Fees for pool admission at the Nassau County parks are noted below. Please note that age and height restrictions apply for the slide and interactive pools at Cantiague Park, North Woodmere Park and Wantagh Park. **Non-swimmers at these locations will be required to rotate between the training pool and interactive pool. In the interest of safety, if these pools are near capacity, you will be required to split your group into two different time periods (open space fees will apply if your group is placed outside of the pool area).**

**Beach Use Requirements:** All camps and organizations are prohibited from using the pools at **Nickerson Beach Park** due to the pools limited capacity. The group/organization requirements regarding the Lifeguards/PAL and Safety Plan for the use of the pool apply to the use of the beach.

**Payment:** Payment must be made upon your arrival to the facility at the time of your visit by MasterCard, Visa, Discover, American Express, cash or check made payable to the "TREASURER OF NASSAU COUNTY". If payment cannot be made daily, please call the park to discuss.

### **Nassau County Pool Use Fees:**

#### **Christopher Morley Park**

*\$6 fee for residents and \$11 fee for non-residents per child*

*\$8 fee for residents and \$16 fee for non-residents per adult*

*\$6 fee for residents for persons with disabilities*

#### **Cantiague Park, North Woodmere Park and Wantagh Park**

*\$6 fee for residents and \$20 fee for non-residents per child*

*\$10 fee for residents and \$25 fee for non-residents per adult*

*\$6 fee for residents for persons with disabilities*

### **Proprietary Groups**

If your group plans on utilizing any other areas of the park other than the pool, the open space fee is applicable at the rate of **\$190.00 per day for use of the courts (with the exception of the tennis courts which are subject to a fee of \$7.00 per hour), playground areas, or for any utilization of the park during the day.** The open space fee may be paid daily with your pool admission. Picnic grounds have additional fees and special arrangements must be made through the park manager prior to your visit. **Athletic field use is by permit only and is subject to additional fees.** Ball field permits at Cantiague Park must be arranged for through Mark LaMarr via e-mail at [mlamarr@nassaucountyny.gov](mailto:mlamarr@nassaucountyny.gov) or by calling 571-7009. All other Ball field permits must be arranged for through Dave Graziosi via e-mail at [dgraziosi@nassaucountyny.gov](mailto:dgraziosi@nassaucountyny.gov) or by calling 572-0521. All proprietary groups must also pay **\$45.00 per day** for each bus entering the park. **Buses must remain in the park for the duration of your campers visit. Proprietary groups are limited to three days per week.**

### **Non-Profit Groups**

If your group plans on utilizing any other areas of the park other than the pool, the open space fee is applicable at the rate of **\$50.00 per day (\$25.00 per hour with a minimum of 2 hours) for use of the courts (with the exception of the tennis courts which are subject to a fee of \$7.00 per hour), playground areas, or for any utilization of the park during the day.** The open space fee may be paid daily with your pool admission. Picnic grounds have additional fees and special arrangements must be made through the park manager prior to your visit. **Athletic field use is by permit only and is subject to additional fees.** Ball field permits at Cantiague Park must be arranged for through Mark LaMarr via e-mail at [mlamarr@nassaucountyny.gov](mailto:mlamarr@nassaucountyny.gov) or by calling 571-7009. All other Ball field permits must be arranged for through Dave Graziosi via e-mail at [dgraziosi@nassaucountyny.gov](mailto:dgraziosi@nassaucountyny.gov) or by calling 572-0521. All non-profit groups must also pay **\$30.00 per day** for each bus entering the park. **Buses must remain in the park for the duration of your campers visit and must be available as shelter in the event of inclement weather.**

Miniature Golf and Batting Cages are available at Cantiague Park for an additional fee and can be reached by calling 571-7058 or 571-7056. Miniature Golf and Batting Cages are available at Eisenhower Park for an additional fee and can be reached by calling 572-0407. Miniature Golf is available at Wantagh Park for an additional fee and can be reached by calling 571-7460. Visits must be prearranged and are limited to 15-20 people on the course at a time. Spray Parks are available at Bay Park (571-7245) and Eisenhower Park (572-0407). Visits must be prearranged.

**Insurance Requirements: All camps and organized groups, including, but not limited to, Day camps, Church groups and Daycare camps are required to provide a Certificate of Insurance as per the following requirements:**

**INSURANCE:** (a) Permittee shall furnish with the application herein a certificate of liability insurance issued to Permittee and naming the COUNTY OF NASSAU as additional insured with respect to the ownership and use of the Property. The County of Nassau, its officials, employees, volunteers, agencies and representatives are included as an additional insured under the commercial general liability policy. A waiver of subrogation is granted in favor of the County. The limits of liability in such policy shall not be less than three million dollars (\$3,000,000) per occurrence for all damages arising out of personal injury and bodily injury, including death at any time resulting therefrom, and destruction to property, and three million dollars (\$3,000,000) aggregate coverage. Such insurance is to be kept continuously in force during the currency of this Permit and any renewals thereof, and shall be written by a carrier licensed to do business in New York State and satisfactory to the County. The premium for such insurance is to be paid by the Permittee.

(b) **WORKERS' COMPENSATION:** In the event that Permittee engages, or intends to engage, employees for any purpose during the period of the permit, Permittee will furnish a certificate of current workers' compensation insurance to cover all such personnel.

**INDEMNIFICATION; DEFENSE; COOPERATION:** (a) The Permittee shall be solely responsible for and shall indemnify and hold harmless the County, Parks and its officers, employees, and agents (the "Indemnified")

Parties”) from and against any and all liabilities, losses, costs, expenses (including, without limitation, attorneys’ fees and disbursements) and damages (“Losses”), arising out of or in connection with any acts or omissions of the Permittee or a Permittee Agent, regardless of whether due to negligence, fault, or default, including Losses in connection with any threatened investigation, litigation or other proceeding or preparing a defense to or prosecuting the same; provided, however, that the Permittee shall not be responsible for that portion, if any, of a Loss that is caused by the negligence of the County.

(b) The Permittee shall, upon the County’s demand and at the County’s direction, promptly and diligently defend, at the Permittee’s own risk and expense, any and all suits, actions, or proceedings which may be brought or instituted against one or more Indemnified Parties for which the Permittee is responsible under this Section, and, further to the Permittee’s indemnification obligations, the Permittee shall pay and satisfy any judgment, decree, loss or settlement in connection therewith.

(c) The Permittee shall, and shall cause Permittee Agents to, cooperate with the County and Parks in connection with the investigation, defense or prosecution of any action, suit or proceeding in connection with this Agreement, including the acts or omissions of the Permittee and/or a Permittee Agent in connection with this Agreement.

(d) The provisions of this Section shall survive the termination of this Agreement.
