

# **Comptroller's Office Mid-Term Review**

Over the past two years, audits completed by the Office of the Nassau County Comptroller have identified over \$23 million in waste, fraud, abuse, and inefficiency and recovered \$7.6 million in taxpayer dollars. These results, along with others, stem from the establishment of four critical priorities for the Comptroller's Office:



## **Opening and Modernizing Nassau County Finances**



Open Nassau Transparency Portal (opennassau.nassaucountyny.gov)

A robust open data platform to modernize the County's finances and make them easily accessible to the public. The Open Nassau Transparency Portal includes: Open Checkbook, Open Payroll, Open Budget, and Open Finance.



#### The Comptroller's Scorecard

A data-driven transparency dashboard that displays the key indicators the Comptroller's Office utilizes to measure Nassau County's fiscal health.



## **Smart Audits to Ask Tough Questions**

#### **Focusing on Results**

In 2018, our team implemented a new policy establishing a follow-up review of our audits. The new follow-up procedure provides updates, increases accessibility for taxpayers and ensures that the corrective actions recommended in the audits are implemented.

One of the key priorities of the Comptroller is the focus on conducting smart audits that produce results. Since taking office, the Comptroller's Office can point to

### **Nepotism Audit**

The first chapter on the Nassau County Board of Ethics was released in 2019. As a result, the Board of Ethics has implemented many of our audit recommendations to improve its major mission of education to prevent ethical missteps.

## The Board of Ethics has already implemented the following recommendations from our Nepotism Audit:



- Improved Board of Ethics website to make it more informative and visible;
- Ensured full membership of Board of Ethics;
- County-wide ethics training including nepotism:
- Implemented an electronic filing for financial disclosure forms;
- Issued the required annual report.



## **Clean Up and Reform County Contracting**

In 2019, the Comptroller's Office has implemented a number of efficiencies to decrease the amount of time it takes for critical review of payment claims to be completed, while also enhancing oversight:

Claims were approved by the Comptroller's Office

Increase in approved claims per year, accounting for increase in volume

Claims approval rate resulting from standardizing review process and enhancement of oversight

#### **Electronic Claims & Vendor Portal**

The new vendor claims process eliminates paperwork, enabling vendors to submit claims electronically through an online portal and have them reviewed and approved electronically by County Departments and the Comptroller's Office. These changes make doing business with Nassau more transparent and business-friendly while allowing for even greater oversight.
