PRAXIS PUBLIC RELATIONS, INC. AND COMMUNITY HOUSING INNOVATIONS CONSULTANT AGREEMENT

This letter constitutes the agreement whereby COMMUNITY HOUSING INNOVATIONS agrees to retain PRAXIS PUBLIC RELATIONS, INC. ("PRAXIS") to perform certain consulting and related public relations work as defined herein on behalf of COMMUNITY HOUSING INNOVATIONS.

The agreement between **COMMUNITY HOUSING INNOVATIONS** and **PRAXIS** shall begin **May 1, 2020** and may be terminated upon thirty (30) days 'notice by either party.

In consideration of the services to be provided by PRAXIS to COMMUNITY HOUSING INNOVATIONS. COMMUNITY HOUSING INNOVATIONS agrees to pay Praxis a monthly stipend of \$5,000 to be billed by Praxis and due each month. \$1,000 of this monthly retainer will be allocated for lobbying activities. Monthly payments shall be sent to: Paul Tonna, Praxis Public Relations, Inc., 69 Chichester Road, Huntington, New York 11743. In no event shall COMMUNITY HOUSING INNOVATIONS be liable for interest, penalties, expenses or attorneys fees for late payment.

In addition to the above, **COMMUNITY HOUSING INNOVATIONS** agrees to reimburse **PRAXIS** for any out-of-pocket expenses which may be incurred in connection with the performance of this agreement and subject to reimbursement only when authorized and approved in advance by **COMMUNITY HOUSING INNOVATIONS**. **PRAXIS** does not anticipate any reimbursable expenses, except when requested by **COMMUNITY HOUSING INNOVATIONS**.

It is agreed and understood between **COMMUNITY HOUSING INNOVATIONS** and **PRAXIS** that this relationship, as defined herein, is that of an independent contractor and that it does *not* involve an employer/employee relationship in any manner.

It is expected that PRAXIS will provide consulting and related services to COMMUNITY HOUSING INNOVATIONS in connection with, but not limited to, the following services and activities ("Services"):

- Assist in increasing COMMUNITY HOUSING INNOVATIONS' visibility, networking and positive name recognition within the Long Island municipal (counties, towns, villages, energy utilities, etc.) and business communities;
- Assist COMMUNITY HOUSING INNOVATIONS in facilitating positive governmental relations & problem solving with CHI clients and assist with land development, building and construction issues with local governmental entities (counties, towns, villages, etc);
- c. Assist COMMUNITY HOUSING INNOVATIONS in developing a strategic approach to pre-development and site plan approval coordination with developers, real estate professionals, municipal governments, etc. This shall include meeting on a regular basis with the assigned management of COMMUNITY HOUSING INNOVATIONS The purpose of these meetings will be to promote the work of COMMUNITY HOUSING INNOVATIONS and to assist in problem solving when requested;
- Assist in construction labor relations, press relations, etc. on behalf of COMMUNITY HOUSING INNOVATIONS when requested.
- e. Assist **COMMUNITY HOUSING INNOVATIONS** in problem solving and strategic planning with local municipalities, public & private organizations, civic groups, utilities, environmental groups, etc.

- Provide, when requested by COMMUNITY HOUSING INNOVATIONS, research regarding appropriate legal, traffic consultants, environmental, etc. firms that can effectively service the organization in a given municipality;
- g. Meet on a regular basis with the designated representatives of COMMUNITY HOUSING INNOVATIONS to discuss, problem solve and design an action plan regarding all issues related to the goals of COMMUNITY HOUSING INNOVATIONS in the Long Island marketplace.

PRAXIS shall not, without **COMMUNITY HOUSING INNOVATIONS'** prior written consent on each occasion, release or disclose any information relating to **COMMUNITY HOUSING INNOVATIONS** that it learns in the course of its services hereunder and that is not generally known to the public to anyone, except as necessary to perform its duties hereunder.

PRAXIS shall provide the Services in accordance with the degree of skill and care exercised by first class consultants providing services for projects of comparable size, complexity and other characteristics as the Services being provided pursuant to this Agreement.
