ATTENTION ALL VISITORS





You are not permitted to be in possession of <u>any</u> personal items or articles (**contraband**) while in the visiting room and all of the pockets/pouches of your clothing must be completely empty. All personal items or articles must be properly secured prior to entering the visiting room. <u>Nothing may be passed to an inmate during a visit</u>. You are subject to search at any time to ensure that you are not in possession of contraband.

Contraband includes, but is not limited to, the following.

- 1. Any weapon or other instrument capable of causing physical injury by being used as a weapon;
- 2. Any quantity of marijuana;
- 3. Any quantity of illegal drugs other than marijuana that would constitute a crime under the New York State Penal Law;
- 4. Any quantity of prescription or over-the-counter drugs;
- 5. Any quantity of tobacco or tobacco products;
- 6. Any type of smoking paraphernalia or smoking-related devices;
- 7. Any lighters, matches, matchbooks, matchbook strikers, or similar devices;
- 8. Any candy, gum or other food items;
- 9. Any quantity of alcohol;
- 10. Any type of voice recording, video recording, or photographing devices;
- 11. Any cell phone, beeper or other electronic communication devices;
- 12. Any check, coin or paper money of any type or kind;
- 13. Any papers, documents, photographs or writing utensils of any type or kind;
- 14. Any article or substance the possession of which would constitute an offense as that term is defined in the New York State Penal Law; and
- 15. Any other item or article which is capable of such use as may endanger the safety or security of the facility or any person herein.

Your visit may be terminated for violation of any facility rules. You will be denied your visit if you appear to be intoxicated or under the influence of drugs. Drug dogs patrol inside the facility and on facility grounds. Any visitor found to be in possession of contraband or defacing/damaging facility property will be subject to arrest and prosecution to the fullest extent of the law.
